If you have a pet in your car and you get into an accident, you may be unable to take care of your pet. To make sure your pet is cared for as you would like, prepare a Pet Instruction Letter and place it in your wallet with your driver's license so that emergency personnel will find it.

In your Pet Instruction Letter you can also include any pets that you have at home that will need attention in your absence. I have prepared a Pet Instruction Letter which you can use.

With this simple letter, you can be assured that the care needs of your pet will be known and attended, even if you cannot see to them yourself.

## PET INSTRUCTION LETTER

In the event that I, \_\_\_\_\_, am incapacitated and unable to make my wishes known regarding my pet(s), please honor the following requests:

My emergency contact person listed below is to be contacted as soon as possible. All expenses for my pet(s) will be guaranteed by them.

If my pet is not injured and my emergency contact person listed below cannot be reached, my pet is to be cared for by my veterinarian listed below or the nearest reputable boarding kennel, and kept in the best possible manner until arrangements can be made to get my pet home.

I prefer that my veterinarian be contacted regarding decisions on my pet's care and treatment.

If my pet is injured beyond all hope of recovery, he or she is to be humanely euthanized.

The welfare of my pet is my primary consideration.
