Many people are concerned with protecting their home. The problem is, if you ever need help from the government to pay for your long term care, when you die, the government will force your home to be sold and the money from the sale will be used to pay back the government loan. This is true because the government allows you to have a home and \$2,000 in financial assets. If you were to simply gift your home to the children, your children would have a tax problem roughly equivalent to 20% of the selling price when the home gets sold, either during your lifetime or after your death.
